The successful quotationer is required to submit the insurance policy to the Office of the undersigned within one month from the date of receipt of premium. The delay in submission of the Insurance Policy may lead to rejection of quotation at the risk and cost of the successful quotationer.

Additional information, if any required, may be had from the Office of undersigned on all working days.


